Section 147(f) Approval to enter into Written Agreement

The undersigned Burgess is an elected officer of the Burgess and Commissioners of Walkersville, MD, a municipal corporation of the State of Maryland (hereinafter referred to as "Municipality"). Pursuant to section 147(f) of the Internal Revenue Code of 1986, as amended (the "Code"), a duly advertised public hearing of the Municipality was held at Town Hall, 21 West Frederick Street, Walkersville, Maryland 21793 on Wednesday, May 8, 2024, at 7 p.m., regarding the public approval requirement for a private activity bond to finance the acquisition of equipment by Walkersville Volunteer Rescue Company consisting of one (1) New Pierce Velocity Heavy Rescue Truck in an aggregate principal amount not to exceed \$1,300,000.00 ("Private Activity Bond"). The equipment acquired with the Private Activity Bond will be located at the station house of the Walkersville Volunteer Rescue Company, Inc. As resolved following the public hearing, the Municipality hereby approves the Walkersville Volunteer Fire Company, Inc. entering into the Agreement with _____ for the Private Activity Bond and further authorizes the undersigned Official to execute and deliver this document on its behalf. **This approval and this document do not in any way constitute the financial involvement, liability, or obligation of the Municipality under or related to the Agreement and no public money is being expended.**

Furthermore, this document acknowledges that for valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Walkersville Volunteer Rescue Company, Inc has provided firefighting and other services for the Municipality for many years and Walkersville Volunteer Rescue Company, Inc hereby agrees to meet the requirement to continue to provide firefighting and other services for the Municipality.
