Economic Development Commission and Planning Commission interaction – Discussion included setting up a Work Session with the Planning Commission to introduce our selves and establish communication between the two groups.

Update on FoodPro – Food Pro is now the owner of record of the former 106 acre Bower Farm at the corner of Biggs For Rd and Fountain Rock Rd. A letter from their attorney to the town has been received in regards to the planning process and requesting the whole farm be put into 'Light Industrial' as the ~40 acre adjacent parcel along Fountain Rock Rd is zoned. A formal Annexation request has not yet been received. Sue Hauver provided the packet from the 01-26-23 Work session with the Planning Commission and the Council for the EDC to review. The town is seeking new Counsel as the towns attorney has a conflict of interest in the Food Pro project.
