## Minutes Economic Development Commission Meeting May 15, 2023

## Motion to approve March minutes made by member McNally, seconded by member Estridge. Passed 4-0

- Discussion about electing new officers. Since two members absent, decided to table until next meeting. Chair Morgan briefly explained roles of officers-Chair, Vice Chair, Secretary.
